Continual expansion of sales and service network

Now with Asaf Industries Ltd in Israel

Since the merger between the injection moulding machine activities of Sumitomo Heavy Industries (SHI) and those of the Demag Plastics Group in the spring of 2008 the Japanese-German machine builder domiciled in Schwaig has continually expanded its sales and service activities and aims to build up a strong presence in all major industrial countries. A reputable partner has now been found in ASAF Industries Ltd for the continuing expansion of sales and service activities in Israel.

Sumitomo (SHI) Demag needed to find a competent partner for its increasing activities in Israel, a partner with expertise in after sales service on the one hand and who has market acceptance and experience of the industry on the other, especially as Israel has many enterprises that are active in the field of medical technology. The packaging and toy market are also of interest. ASAF is a commercial agency that is well established in Israel's plastics industry. Israel's economy has made a marked recovery since 2009 and the country has emerged from the crisis



relatively unharmed. It is true, however, that the industry's investments in machinery and equipment suffered a significant decline in 2009, falling in real terms by 36.9%. This caused the investments in machinery and equipment accounted for by the industry to fall from 49.6 to just 30.4%. "But," says Christian Renners, General Manager of the Sales & After Sales business unit at Sumitomo (SHI) Demag, "this means that there is a need to catch up which will gradually be satisfied". The business community's capital expenditure on imported machinery and equipment fell by 23.3% in 2009, whereas this decrease was only 3.9% in the case of domestic products. Consequently, the proportion of foreign goods making up the business community's investments in machinery and equipment declined from the record level of 72.4% reached in the previous year to 67.8%. According to Renners, however, there will be no change in the dominance of foreign machinery in Israel in the near future.
